Attendance Policy

1. Regular attendance is mandatory at all lab, clinicals and scheduled mock skill days in order to achieve the objectives of the program. Students who are absent from any assigned lab or clinical days will be automatically withdrawn.



- 2. If you are not present when attendance is taken for class, it will be counted as an absence. Attendance can be taken at any time.
- 3. Attendance is mandatory for all lab and clinical sessions. Extenuating circumstances may interfere with attendance. In these circumstances students need to contact their instructor, regarding their absence from lab or clinical immediately. Alternate arrangements for students to complete missed hours will be attempted, however, this is not guaranteed. If alternative arrangements are not available, the student's participation in the course will end.
- 4. Absence from **clinical** or lab must be **reported to the instructor at least one hour** before clinical begins.
- 5. You will not be excused or leave early from lab, or clinical assignments for functions, employment, or for any other reason. Schedule medical, dental, and other appointments at times other than scheduled class hours.
- 6. Attendance strongly correlates to successful completion in the Nursing Assistant program.
- 7. It is expected that you remain in lab or clinical setting once class has begun. It is extremely distracting for the instructor as well as for other students when there is activity during presentations. Scheduled breaks allow you to get up and move around if necessary.

At the conclusion of the Nursing Assistant Program, graduates receive certificates of completion. Graduates are qualified to work as nursing assistants upon successful completion of the Wisconsin Nurse Aide competency exam conducted by HEADMASTER.
